COACH CODE OF CONDUCT

I agree to conduct myself in a manner that displays sportsmanship; serve as role model to the boys and girls in my care; refrain from the use of crude or abusive language with players, opponents, officials or spectators; avoid behavior that will incite players, opponents or spectators; avoid the use of drugs, including alcohol and tobacco, in the presence of players and spectators. I agree to maintain professional, adult conduct at all practices, games or functions associated with the team. I agree to instruct players in the elements of good sportsmanship and remove players from practice or competition who demonstrate unsportsmanlike behavior. I will conduct myself in an ethical manner; respect the integrity and judgment of sports officials; approach competition as healthy and constructive. I agree to plan my practices, be professional, be prepared, and be organized. I will adhere to all D5SAC policies and rules. I will arrive 15 minutes before practice and will stay at practice until all children have left with a parent. I will keep parents informed of cancellations, reschedules, banquet information, etc. I will have a plan in place to deal with injuries. I will instruct and insure that players keep all practice and playing areas clean. I will report any change in my status to D5SAC including but not limited to criminal arrests. I agree to coach the system, methods and playbook required by D5SAC. I will be personally responsible for all equipment issued from D5 SAC. I will maintain necessary coaches certification and will continue to educate myself on the sport and coaching techniques.

Appropriate Conduct of D5SAC coaches and Directors

Violations of this policy by volunteers will be grounds for immediate suspension and possible termination. The following list includes some of the actions that are considered misconduct while on duty on or off premises: possessing, using, selling, manufacturing, distributing or dispensing any illegal drugs or alcohol while on duty or off district property, fighting or deliberately harming another; failure to adhere to safety rules as established by D5SAC; destroying property intentionally; using obscene language; having any interaction/activity of a sexual nature or intent with a student; possessing weapons on school property (unless otherwise authorized by law); harassment, intimidation or bullying of others.

Arrest of a coach / Director

The D5SAC board of directors has authority to take appropriate action with regard to a coach who has been arrested. Coaches/Directors arrested for a misdemeanor offense which would indicate no danger or appearance of danger to children will normally not be subject to any action. Coaches/Directors arrested for a misdemeanor offense which would indicate a possible danger or appearance of danger to the students will normally be suspended. Coaches/Directors arrested for a felony offense will normally be suspended.

Probation of a Coach/Player

If a coach or player is placed under probation from the Board of Directors of D5SAC, the Board of Directors have the authority to remove the person from all D5SAC activities for any violation of organizational policies to protect the interest of the league and those being served.

Volunteer Release of Liability

I, \_\_\_\_\_, acknowledge that as a volunteer for the D5 Sports and Activities Council (D5 SAC), I am not an employee of the D5 SAC and am not entitled to receive salary, benefits or other compensation. I further understand that I do not qualify for workers' compensation benefits and am expected to carry personal medical insurance to cover medical expenses for any injuries I incur while performing volunteer services. As consideration for participating in volunteer activities, I hereby agree that I, my assignees, heirs, spouses, guardians and legal representatives will not make a claim against, or sue, the D5 SAC, agents, and any other persons, agencies, firms or corporations affiliated with D5 SAC from all actions, claims or demands that I, my assignees, heirs, spouses, guardians, and legal representatives now have or may hereafter have from any liability, whether currently known or unknown, resulting from my participation as a volunteer. This release of liability and assumption of risk, in addition to covering any past occurrences, is intended to discharge in advance their respective successors and assigns from and against any and all liability arising out of or connected in any way with my participation as a volunteer for the D5 SAC even though that liability may arise out of negligence or carelessness on the part of the persons or entities above mentioned or any other cause.
